Resumen

PLANTEO DE LA PROBLEMÁTICA

A lo largo de los últimos años ha cobrado renovado impulso el desarrollo de los juicios por causas de Crímenes de Lesa Humanidad perpetrados por el Terrorismo de Estado de la última Dictadura cívico-militar. En este marco se abren condiciones de posibilidad que permiten hacer lugar a viejas presentaciones del padecimiento humano que no habían sido atendidas anteriormente.

Los actores institucionales nacionales e internacionales, interesados en la recomposición del tejido social dañado por los efectos psicosociales de la violencia del Terrorismo de Estado y de la Impunidad, han destacado la importancia que tiene para la metabolización de los procesos de macrovictimización como el referido la implementación cabal de los procesos de Justicia que correspondiesen.

Hay consenso en señalar la especial importancia de contar con dispositivos específicamente pensados y diseñados para el acompañamiento de las víctimas de crímenes de Lesa Humanidad en situación de acceso a la justicia, dado el déficit existente en los procesos judiciales a la hora de apoyar y asistir a los testigos-víctimas.

En Argentina, a diferencia de otros países del mundo, se cuenta con algunas experiencias orientadas al acompañamiento de testigos-víctimas.
